Overall, great work! Also notable is the active participation during the course.

At the same time, the recommendation part is rather general – outlining potential reform areas in broad terms without going into specific details about the realism of reform actions. Most of the reform proposal also lack a reality check concerning their feasibility in a tightly controlled state environment. Notable is the good participation during the seminar.
0334285	25	Reasonable paper which summarises some key governance issues and challenges. The recommendations part is rather general – it only points to some major reform avenues (e.g., participation, relationship with the military) without providing details or an assessment about the feasibility of such reforms in a tightly controlled state

0333356	27	Good paper which summarises relevant governance issues and challenges and outlines a range of sensible and practical proposals to address prevailing governance issues and risks. Some more evaluation about feasibility and realism of reform actions in Ragana (e.g., on transparency and participation issues in a tightly controlled state) would have been beneficial.
0333803	28	Excellent paper which focuses on the key developmental and governance challenges of the case, in particular on how to overcome the resistance of the military. I liked the recommendation part which is succinct and focused on generating buy-in into much needed governance reforms (although I remain somewhat doubtful that a complex program as proposed in the paper is implementable in Ragana's weak governance environment). Overall, well done!
0334238	25	Rather general paper with some insights into economic governance issues and challenges of the case. The recommendation part is rather generic with little details about proposed actions to go forward. The paper would have benefitted from a discussion about reform priorities, an assessment of realism and feasibility of proposed reform actions in a tightly controlled state environment. Notable is the good participation during the seminar.
0333668	25	Reasonable paper which by-and-large summarises some of the prevailing governance issues around the case and outlines a few avenues of reforms. Most of the reform proposals would have benefitted from a more substantive assessment and are missing an analysis of realism and feasibility of proposed reform avenues in a tightly controlled state environment. At the same time the paper discusses the change management issues and challenges in some detail which is certainly one of the key building blocks for a potential engagement in Ragana.
0333937	28	Excellent paper based on a sound analysis of the prevailing governance risks and issues. I liked, in particular, the discussion about transparency and participation issues which certainly goes to the heart of governance issues. The recommendation part entails some convincing proposals – it would have benefitted from more discussion about prioritization and feasibility before the background of a tightly controlled state and government. Overall great work!
